






China Sourcing Office - Suzhou





Proactive Quality Control

Quality control isn't just about appearing at the end of production to identify problems. At Liya Solutions, we prioritize supplier training and collaboration. We conduct thorough inspections before, during, and after production, offering timely feedback to rectify issues promptly and guarantee top-notch quality for our clients.

Quality Control We work hard so you don't have to worry about:

Pre-production Inspection

Our Factory & Environment Assessment (FEA) encompasses environmental and ethical production conditions. The Pre-Production Check (PPC) ensures adherence to your specific production specifications. This customized assessment can be combined with the Factory Quality Assessment (FQA), where a factory can be evaluated prior to placing an order, in accordance with your needs.

In Process Quality Control

The IPQC is the inspection of products on the production line before the manufacturing process is completed to confirm compliance with the specifications. Monitoring the production process mitigates the risk of subpar quality and ensures fulfillment of all contractual obligations. Timely detection of potential execution issues allows for more efficient and effective corrective actions.

Pre-shipment Inspection

Final Random Inspection (FRI) is the detailed visual inspection of goods before shipment. It is generally conducted on the premises of the manufacturer on samples selected according to defined sampling procedures. The inspection criteria covering quality, quantity, marking, and packing are based on your provided specifications and reference samples. Upon completion of FRI, a detailed inspection report is sent to you and our inspection certificate is issued to the supplier if all findings are positive.

Container Loading Supervision

We ensure that your goods are loaded properly and that the containers are not defective or unsanitary. Damaged containers, such as those with broken welding seams or gaps, particularly on the roof, pose a high risk of water damage from seawater or rain.
